

Minutes of the Peterborough Field Naturalists 81st Annual General Meeting Wednesday, March 10, 2022 at 7:00 p.m. (Zoom Meeting)

1. Call to Order

President Rene Gareau called the meeting to order at 7:00 p.m. and welcomed the participants. The Zoom meeting was attended by 37 members of the Peterborough Field Naturalists (PFN).

President Gareau stated that the number of members attending by Zoom due to the Covid-19 pandemic exceeds the quorum required by the Peterborough Field Naturalists Operating By-law for a Members' Business Meeting.

The following documents were attached to the meeting notice that was sent by email to members: Agenda, Minutes of the 80th Annual General Meeting (March 3, 2021), Annual Report for 2021, Financial Statements 2021 and Treasurer's Report, and Report of the Nominating Committee. 4. President's Report 2021

That the requirement for an external audit or review of the PFN Financial Statements for 2021 under the Ontario Not-for-Profit Corporations Act 2010 be waived and that the Board of Directors develop a procedure for an annual informal review of the PFN's financial records by a committee including one or more persons not members of the Board of Directors.

PFN member Ian Attridge suggested that in addition to the annual review of the budget by committee that the PFN consider occasionally carrying out a full audit. PFN member Al Sippel supported this suggestion and further indicated such an audit should be carried out every 3 years.

7. Nominating Committee Report

Edward Vale presented the Report of the Nominating Committee. President Gareau asked three times for nominations from members in attendance.

That the Report of the Nominating Committee recommending a three-year term on the Board of Directors for Daniel Cadieux, Phil Shaw, Marilyn Hubley and Reem Ali be approved.
